I understand that Cross Point Ministries, Inc. will not be liable to me in any way for any injury I may sustain while visiting the Retreat. I agree that my group leaders and I are responsible for my safety while traveling to, staying at, and returning from Cross Point Retreat and that Cross Point Ministries, Inc., its officers, directors, employees and agents, are not in any way responsible for my safety.

In consideration of being allowed to visit Cross Point Retreat, I hereby personally assume for myself, or for my minor child, as the case may be, all risks in connection with said program for any injuries or dangers which may occur to myself or my child as participants and do fully and forever release Cross Point Ministries, Inc., its owners employees and agents, Monty Walton and Elizabeth Walton from any and all claims, demands, dangers, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of the participant's use of the facilities, equipment and property of Cross Point Ministries, Inc. excepting only claims arising solely out of the active negligence of Cross Point Ministries, Inc. I do, for myself and on behalf of my minor child as the case may be, agree to indemnify and hold harmless Cross Point Ministries, Inc. and its affiliates and the employees and agents thereof from any liability and expense for personal or property damage or injury not caused by their negligent actions.
